

OAC 3701-21-02.2: Cost Analysis and calculation

(A) A cost analysis shall be conducted each fiscal year. The licensor shall use data from the [previous fiscal year](#) to calculate the [actual cost](#) of administering and enforcing Chapter 3717 of the Revised Code and the rules adopted thereunder for food service operations and retail food establishments licensed by the licensor.

(D)(2) *Anticipated* (emphasis added) increases in costs that may be attributable to a component are limited to [known increases](#) for which official notification or board action has been documented.
