
- Met with a client for a 504 evaluation on 12/19
- Working with a client to resume services after several years without. This client has been difficult to contact and having difficulty compiling information necessary for the application
- A total of \$4150 has been received for the year.

#### Car Seats

- Ohio Buckle Buckeyes (OBB) Site visit took place on December 18<sup>th</sup> by Ann Roderer. The site visit went well and was successful.
- A class was scheduled on December 6<sup>th</sup>, but was missed and rescheduled for the 7<sup>th</sup> but was missed again.

## **Immunizations**

- Three clinics were held during the month of December
- Vaccines administered During the 4<sup>th</sup> Quarter, were 123.
- October-December no show rate is 21.43%



#### Get Vaccinated Ohio - Grant

- Reports from ImpactSIIS for AFIX quality improvement were pulled and sent to ODH on 12/7.
  - o These reports include the rates of fully vaccinated 0-2-year-olds and 13-17-year-olds.
  - Strategies will be developed to improve the rates.
    - Currently working on a recall of all children last seen by the Galion City Health Department will be sent a postcard to encourage making an appointment for missed immunizations
- Galion pediatric offices of Dr. Brown and Dr. Eckstein were visited on 12/19 to encourage the MOBI and TIES trainings and performing AFIX quality improvement strategies. Met with Cari Strine, Avita Health Services Manager leaving forms for permission to access immunization rated through Impact as well as information on MOBI, TIES and AFIX.
- Crawford County was invoiced for a total of \$1230.

- This included a perinatal case which was clarified with the state and has been removed due to misunderstanding of reimbursement.
- \$480 was then correctly invoiced for AFIX Assessment and Feedback completion for the Galion City Health Department
- Total of \$3310 has been reimbursement by Crawford County for this grant.

# Flu

 Surplus VFC flu was considered and offered to the local pediatrician's offices. 30 doses were transferred to Dr. Eckstein's office.

#### Lead

- Lead education for elevated lead levels continue. Two children were referred from a local
  pedestrian office for lead case management. The levels of the two children were 5 and 10
  micrograms per deciliter. When a lead level is 10 or greater, the state will perform a lead home
  investigation. These cases will be managed to ensure the children are being routinely tested as
  needed.
- Lead tests was completed on 12/10 and 12/17 both with a normal value.
