

RESOLUTION #2019-158

A RESOLUTION TO SET ENVIRONMENTAL HEALTH FEES FOR 2020, AND REPEAL RESOLUTION 2018-154

WHEREAS, the Galion City Board of Health acting under authority vested in it by Section 3709.21 of the Ohio Revised Code may adopt regulations necessary for public health and safety and the prevention and restriction of disease, and;

WHEREAS, license fees are adopted in the form of rules under authority of Section 3709.09 of the Ohio Revised Code, and;

WHEREAS, the Ohio Department of Health has established rules governing the categories and methodologies for establishing fees, and;

WHEREAS, the adopted fees are necessary to cover the costs of administering the environmental health programs;

NOW, THEREFORE BE IT RESOLVED, by the Galion City Board of Health that, after giving due thought and proper consideration, the following fee schedule be adopted:
