

RESOLUTION #2019- 158

**A RESOLUTION TO SET ENVIRONMENTAL HEALTH FEES FOR 2020, AND
REPEAL RESOLUTION 2018-154**

WHEREAS, the Galion City Board of Health acting under authority vested in it by Section 3709.21 of the Ohio Revised Code may adopt regulations necessary for public health and safety and the prevention and restriction of disease, and;

WHEREAS, license fees are adopted in the form of rules under authority of Section 3709.09 of the Ohio Revised Code, and;

WHEREAS, the Ohio Department of Health has established rules governing the categories and methodologies for establishing fees, and;

WHEREAS, the adopted fees are necessary to cover the costs of administering the environmental health programs;

NOW, THEREFORE BE IT RESOLVED, by the Galion City Board of Health that, after giving due thought and proper consideration, the following fee schedule be adopted:

BE IT FURTHER RESOLVED that should any part of this regulation be declared invalid or unconstitutional for any reason, the remainder of this regulation shall not be affected thereby.

BE IT FURTHER RESOLVED that this rule shall be advertised by publication in one newspaper of general circulation within the health district. Publication shall be made once a week for two consecutive weeks and such rules shall take effect and be in force ten days from the date of the first publication.
