I wanted to highlight a few things we discussed:

- All your products are set to monthly billing/ service for this account
 - The prices for mats (4x6 logo:13.50 & 3x10: 14.50) are fixed monthly cost for each mat
 - The hygiene products listed below the mats (Galionagreement.pdf) are billed on an as needed bases. The driver will have an amount to drop you off each time (managing inventory) that will be on the invoice and will credit or add to reflect the amount you use
 - The first invoice will be the largest to fill dispensers
 - The truck service rep can add additional products and remove existing products when he is servicing your account. He will communicate with the point of contact each time he is there.
- Time to set up an account
 - It takes 2-3 weeks to order & install dispensers. The first service date can be as soon as the dispensers are installed
 - It takes 3-4 weeks for the logo mat to come in
 - I will bring mats out before your service free of charge and will give you a standard black/gray mat until logo comes in
 - If you'd like to have your logo mat and dispensers ready to go for September 1st, we will need signatures asap
- I attached a logo I found online and think it might look better on gray? If so, I'll make your runner gray as well
- I attached a Dispenser PDF as well What color would you like?
