Moving forward, it is impossible to do both positions any longer (meaning health commissioner and EH Director simultaneously) The Environmental Health work is behind.

There was considerable discussion about moving forward with interviewing and appointing a new health commissioner, including moving forward with a group interview with Dustin Kent to see if he is still interested in the position. Shellie wants to increase our posting using the WFD grant dollars and see if we have a pool of candidates to interview. Mandy mentioned that she was told a former physician recently applied. BOH will continue to interview and observe applicants as the posting increases.

#### 7.2 Director Positions reinstated as Non-Exempt

Discussions continue concerning the two positions: Director of Nursing and Director of Environmental Health being changed back to hourly, non-exempt status. In 2018, the 2 positions were changed to be salaried, exempt. The only salaried, exempt position should be the health commissioner position. BOH is going to table this until we either get a written statement from Thomas Palmer or the law office of Clemons Nelson.
