Went onsite to finish deploying computers to new domain. Because we cannot disconnect the fiber networks, there were conflicting DHCP and DNS servers when leases expired. Since the workstations are limited, we statically assigned all devices that are hooked up over the 10.10.10.x network. The wireless network is also a part of Galion, so we have to factory reset both the switch and the AP. Configured the unifi console on the DC with the 10.10.10.x network, and will use the DHCP range since all the wired computers are static. Need to get with Gflesch for the changes on the scan to file server for users in the office. Also need to reach out to Rick and Sunrize to get Medisoft running on the new domain.
