The Galion City Health Department would like to dispute the most current invoice dated 01/31/2022. I am attaching two invoices that we paid dated 9/30/2020 and 12/31/2020 for the installation and migration of our own server at the GCHD. The Galion City Health Department paid \$14,358.68 for this service which was never properly migrated to our own server. Throughout the course of 2021, the Galion City Health Department employees lost countless hours of work time due to issues stemming from the incomplete migration to our new server. But beyond those issues which ES was always able to correct remotely, I would like to point out that we have highlighted the original bill where GCHD was charged for a minimum of 40 hours, but other invoices show that we only used 10.5 hours one time and this most recent invoice is an additional 27 hours provided by ES on-site to complete the migration.
