Unfortunately, that then did not allow for expenses to be paid for out of the general fund account lines and no money had been moved for health department expenses to be paid. The matter had been taken to City Council and Council approved the Ordinance to transfer the funds into the correct line; however, the Mayor did not sign the Ordinance. Without the Mayor's signature, the Ordinance would not go into effect until 10 days after Council passed it. The 2 expenses and payroll were approved to be paid by the Auditor; however, that left the health department account line in the negative at the end of the month.
