## 5. Approval of Finance Reports/ Warrants

minimal but a determination as to whether or not to pay a portion was needed. Ms. Ault believed we should go ahead and pay it, Mr. Sterling stated if there are 3 departments that we should ask if it can be split in thirds. Ms. Factor will follow-up on this.

# 6.1 COVID Updates

Ms. Factor presented COVID-19 status updates. Discussion on cases and analytics of the cases occurred. Ms. Factor presented the case data is text a graph format. Ms. Factor shared updates on testing, both antibody and antigen testing. Updates were provided on the EOC, situation status, and mitigation efforts. ReStart Ohio initiatives- openings and the attempts to communicate with event organizers and the state regarding limitations or closures still in place; events such as fireworks and other activities surrounding such events.

Mr. Sterling asked to verify the hospitalized cases for Galion. Ms. Factor went through the cases and expressed that there were 19 cumulative hospitalizations. Mr. Sterling asked about how many were in ICU, Ms. Factor did not have that information readily available; she also expressed that with only 1 hospital admission for Galion she wanted to be cautious in sharing any demographics of the case at this time.
