

## WF23 Reallocation Announcement

The Ohio Department of Health is pleased to offer increased funding in the amount of \$90,000 for the Workforce Subgrant Project (WF23) to Local Health Department (LHD) recipients who meet eligibility criteria. Before accepting the additional funds, please consider the following:

- (1) LHDs are encouraged to utilize these funds for critical workforce needs. Please carefully consider your agency's needs and budget accordingly. The maximum reallocation available to eligible LHDs is \$90,000 but you may request less than that.
- (2) Your agency's ability to fully expend your current award plus the additional funding before the WF23 completion date of 11/30/2027. Unspent funds are returned to the federal funding agency and can reflect poorly on Ohio's future funding levels for same or similar programs.

## Eligibility

The list of eligible LHDs is attached. Eligibility was determined using the following criteria:

- (1) LHDs will audit or desk review findings of significance are ineligible for increased funding.
- (2) WF23 recipients who have expended 50% or more of their original award, according to the expenditure report submitted prior to April 27, 2026, are eligible for funding.
- (3) WF23 recipients who have expended less than 50% of their original award but who have less than \$200,000 remaining are also eligible.

Eligible LHDs will find an official letter notifying you of the process for submitting revised budgets attached to the *Comments* section of their WF23 grant in Legacy GMIS.
